Discussion/Possible Decision RE: Kuczarski Land Division Application

Jim Rein, Wilderness Surveying was present and explained that they are involved in this because the court is involved and has asked Wilderness Surveying to look at this division and lay out a parcel that included all of the outbuildings. Jim stated that he was asked by a Court Appointed Attorney to complete the Survey Map. G. Hartman stated that he believes we only have 30 days to make this decision and need to decide tonight if the Board will approve it. Jim stated that it is only one parcel that is being divided from the others. G. Hartman stated that we need to make a decision on it this month. Turgeon stated that it meets the 5 acres and all requirements and there is not a reason to wait.

Motion by Turgeon to approved the certified survey map as presented by Wilderness Surveying on the condition that it is also approved by the Oneida County Planning and Zoning Department. Seconded by G. Hartman. All aye. Motion carried.
