OLD BUSINESS

Discussion/Possible Decision RE: American Asphalt, 2011 Road bids

Ray Gausman, American Asphalt, was present to explain why the road bills came in \$1500.00 over the bid. Gausman explained that the way the Town bid the roads out the supplies were listed less than what ended up being needed and therefore, the bill was higher.

Discussion/Possible Decision RE: Gravel Pit Reclamation Application,  
Klaver/Oneida County

Gene Uttech, MSA, was present to explain the reclamation application for Oneida County. Uttech stated that Oneida County will reclaim the School property gravel pit in the spring. Oneida County will then begin stockpiling gravel on their property.

T. Hartman received a call from Marilyn Tucker asking about the possibility of the Town going back and looking into her Wisconsin Retirement System. Turgeon asked how far back this will need to go. T. Hartman will look into this with the WRS.

Motion by G. Hartman to give the clerk and treasurer permission to pay the bills as they come in for the remainder of 2011. Seconded by Turgeon. All aye. Motion carried.

Motion by Turgeon to approve the operator's license for Anna Kupczak. Seconded by G. Hartman. All aye. Motion carried.
