

Town of Crescent  
Weight Limit Ordinance  
Number 2012-02

The Town of Crescent does hereby adopt this ordinance in accordance with the Wisconsin State Statutes and specifically Chapters 348 and 349.

**SECTION 1**

- 1.1 **Purpose.** The Town Board of Supervisors of the Town of Crescent, Oneida County Wisconsin, find that it is in the best interests of the residents and property owners and taxpayers in the Town of Crescent to determine and regulate the weight limits on certain roads in the Town of Crescent. The adoption of this resolution for such regulation will benefit and promote the safety, welfare and convenience of the public, and prevent the continued deterioration of such roads.
- 1.2 **Statutory Authority.** This ordinance is enacted pursuant to Chapters 348 and 349 of Wisconsin Statutes and this ordinance incorporates all portions of the Wisconsin Statutes found in said chapters as they relate to weight limits, together with all the rules relating to both criminal and civil liability.
- 1.3 **Definitions.** The definitions contained in the statutes referred to above are hereby adopted and made a part of this ordinance by reference.

**SECTION II**

- 2.1 **Establishment of Weight Limits.** No person shall operate or leave standing any vehicle, or combination of vehicles, having a gross vehicle weight in excess of 20 Ton, except as provided herein, on or over the following roads in the Town of Crescent: North Rifle Road from County Hwy K to Round Lake Rd.
- 2.2 **Exceptions.** The restrictions set forth herein shall not apply to authorized emergency vehicles, vehicles engaged in the removal, treatment or sanding of snow or ice, refuse collection vehicles while accessing and serving residences or businesses located on or along said roads, and septic-service vehicles while accessing and pumping septic or holding tanks serving residences or businesses located on or along said roads.

**SECTION III**

- 3.1 **Penalties.** The penalty provisions of Chapters 348 and 349 of Wisconsin Statutes, as amended, are hereby adopted, including without limitation, Section 348.21.
- 3.2 **Issuance of Citations.** The police or constable for the Town of Crescent, if any, and all deputy sheriffs for the County of Oneida, and such other persons as the Town Board may authorize by future resolution, may issue a summons or citation to the owners or operators of vehicles operated in violation hereof.
- 3.3 **Enforcement.** This ordinance shall be enforced according to the Chapter 348 of the Wisconsin Statutes, together with Chapter 799.

BE IT RESOLVED that the foregoing ordinance be adopted and shall become effective on passage and publication.
